Vice President Junior House League- Mark Girard

- A decline in registration this year but an increase in the IP divisions
- Big thanks to Dan Pletch and all the helpers they had on the ice
- Good support from parents in the IP Division
- Smaller nets were acquired this year and it helped with the program
- Also sponge boards
- Atom had 4 teams, and everything went well
- Peewee only had 2 teams

Treasurer-Marg Greaves

- Marg has been the treasurer since the 2015-2016 season
- This will be her last year
- Marg did provide the board and members with the financial statement for the year
- She did clarify some things on the statement
- We were awfully close to budget on registration
- Nevada tickets. The Avondale store at York and King have break open tickets. we receive a portion of the sale.
- This year we received \$6000.00

- Ice Rental: this is one of the biggest chunks of our expenses. This year we received a \$25,000 ice credit that Arlene Vanderbeek had passed at City Council
- Disbursement of players to other city arenas. Saved some money here on ice as well
- Member Equity was approximately \$94,000
- Last year for Marg, thank you to everyone for last seasons

Vice President Rep – Andy Pipe (regrets)report given by Mark Girard

- Andy observed FHA to see how the ran their tryouts
- They have evaluators on ice
- The board members are in the war room
- Names were never brought up only numbers
- The focus was putting the best players on the team
- Going from AA-A- AE proved to be better way.

President/Executive Vice President – Mark Girard

Mark thanked both Marg and Tina for being part of DMHA for such a long time. He also thanked all the DMHA board for volunteering this year. Mark also thanked all the spouses and families of the people who have volunteered noting that a lot of time is put in DMHA and sometimes affects family life.

Last year after the AGM Mark volunteered for the Executive Vice President and then had to step into the President role.

- Mark has been working with the City of Hamilton regarding the new arena at Market St
- Looks like it is still on track. The contractor will finish and then hand it over to the City, who in turn has a few months of work to do.
- Mark has been discussing with the City the full-size boards to divide the ice. We would like them for the start of the season. They will improve the programming in the next years.
- Mark has been having discussions about moving all house league programming back to Market St.
- In talks with Flamborough about shared ice for the Rep teams. As more information becomes available, we will put it on the website and social media.
- We haven't done a lot of special events this year. Need to bring back tag day, pancake breakfast on Champ Day, Santa visiting the younger players etc.
- Also need the volunteers
- We did not have any convenors this year. We did not have the people to step up and help keep the programs running.
- We needed tp have committed VPs and convenors to make our House league program better
- This year we hope to focus on player development. We will start this in September.
- We also will be running select this year, The idea this year will be to run them right from the start of house league. While evaluating house league players also evaluating for select as well.
- Would like to add an additional 3 on 3 this year
- Also going to buy some new equipment for the younger age group and maybe some goalie equipment as well.

Future of DMHA

Dundas and Flamborough are in discussions about branding right now. Full branding was talked about in the beginning for this season. That probably will not happen, and full branding may come the following year. Trying to minimize the cost of jerseys by using excess jerseys from FHA with Dundas branding.

What are the next steps? The new board will work with FHA to ensure smooth running of the pilot project and focus on house league.

This is the second year of the pilot. We have to option to walk awa from it, but to what? Mark has been on the phone with our OMHA Area Manager Paul Wilson prior to this meeting. All eyes will be on the pilot program this year. We encourage you to give feedback and let us know what you see going on. We will probably make decisions mid-season this year.

Question from the floor: Why did the Rep program leave Dundas?

Mark Answered: Moat teams are walk on, tryouts were getting fewer and fewer players. This is not just a problem in Dundas.

Question from the floor: any idea what the HL numbers will look like this year?

Mark Answered: IP-50, Novice and Minor Novice team, Peewee will be a challenge may have to interlock, Bantam 4 teams and Midget 6 teams.

Question from the floor: Some associations are doing select tryouts now?

Mark Answered: we have decided to keep our tryouts in the fall. Interlock will not affect select.
